

## CORTIZONE ITSCHSANE MOVES SWEEPSTAKES

### OFFICIAL RULES

The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participant ("Participant") agrees to be bound by these Official Rules and the decisions of Chattem, Inc. d/b/a Sanofi Consumer Healthcare, (the "Sponsor"), which are binding and final on matters relating to this Sweepstakes.

**2) Instagram:** Create or log in to your Instagram account. Then post your Entry on your personal Instagram page and include the hashtag #ItchsanitySweeps.

**3) TikTok:** Create or log in to your TikTok account. Add a text overlay to Entry that displays the hashtag #ItchsanitySweeps and tags @cortizone10us. Post Entry on your personal TikTok page.

To enter the Sweepstakes using a social media account you must have a public Instagram or TikTok, account. You may obtain an account for free by visiting [www.instagram.com](http://www.instagram.com) or [www.tiktok.com](http://www.tiktok.com), and following their instructions on how to create a profile and/or download the Instagram application ("Instagram") or TikTok application ("TikTok") to your mobile device and follow the prompts to create a profile from your mobile device. Prize will be randomly selected on May 7, 2024. Winners will be randomly selected by the Administrator. Winners will be contacted by a third party via direct message on Social Media Platforms or via email.
